## **Arrangement**

The rolls are listed and kept in chronological order.

The layout of the list of rolls is as follows:

1. Reference (the rolls are referred to by the date of the tourn)

The reference is based upon the number given in the original to the tourn, but the sequence of tourns in the modern year is 3, 1, 2, and for these the seasons Spring, Summer, Autumn have been submitted, even where this seems somewhat incongruous, eg Autumn 1400.

2. Opening date as given in the heading

No attempt is made to indicate dates found in headings other than the main heading, either earlier or later, contemporary or subsequent.

3. Officials named in the heading

No attempt is made to supply the names of officials where they are wanting, eg rolls from the 1490's headed "coram prenominatis", presumably because they were sewn to a roll for an earlier tourn.

- 4. Notes (where relevant) on the dating etc.
- 5. Cross-reference to printed extracts (the volume concerned [Surtees Society, 82] only covers the period 1296-1384

No attempt is made to call in question the dates of clearly headed rolls, eg Summer 1506, where the opening date as given falls on Saturday.

One or a series of dots is used to indicate losses from the manuscript, a dash an omission, and square brackets additional supplied or inferred information.

#### Form of citation

The form of citation should be GB-0033-DCD-Halm. rolls, or the collection title Durham Cathedral Muniments: Halmote Rolls, and the *date*.

To order items in the searchroom, use the collection reference code(s), derived by removing the repository code (GB-0033-), followed by the reference number. Citing the section of the finding aid is useful.

Where necessary, identification of townships is based on the names of tenants given in the Bursar's Rental for 1340/1, or failing that on entries elsewhere among these leaves.

On the assumption that no township appears twice at any one tourn, it is possible to exclude f.ii (Newton Ketton) and 3 (Chilton) as well as ff.2 and 213v (other tourns) as belonging with f.1, leaving ff.213 and 213r, likewise ff.212 (Raintons) and 3 (Billingham) as well as

ff.1 and 2 (other tourns) do not belong with f.213v, leaving f.ii, and ff.212-213r (Shields) and ii (Wearmouth and Fulwell) as well as ff.1 and 213v do not belong with f.2, leaving f.3.

It seems that ff.1 and 212 and 212 and 213 are consecutive leaves, with the entry for one township running on from one leaf to the next.

That being so, f.213 has the last entries for a third tourn, and so f.213v presumably refers to the next tourn, the first tourn in 1339, and hence the preceding third tourn would have been that of 1338.

It cannot be demonstrated conclusively that ff.213-213r refer to the same tourn as f.1; or f.ii to the same tourn as f.213v; or f.3 to the same tourn as f.2. Nevertheless, their appearance does not suggest otherwise and it is possible that the six leaves originally belonged to two quires, each of four leaves, of which the last leaf of both is now missing.

The first leaf is missing, save for a small fragment with the marginal heading "Jarow" on the recto. As the first surviving heading, f.3r, is for the second, i.e.the Autumn, tourn 1400, the entries that precede it are taken to belong to the first, the Summer, tourn; these entries are also found on a separate headless roll, while those for the autumn tourn are on another roll. There is nothing from the Spring tourn 1406, f.13v being left blank and the following leaf removed; most of the entries from the Autumn tourn 1428 and the Spring tourn 1429 are missing through the loss of f.101. There are records from separate sessions of the court at Edmundbyers on 27 Sept.1429 and 12 June 1432, f.120rv, and on 29 April 1434, f.130rv; and at Burdon on 23 March 1429/30 and 6 May 1432, f.125rv. The entries for the Summer tourn 1440, f.159v-161v, are repeated on Halmote Book II f.1r 3r.

The full headings from the halmote rolls are not given here, only the number of the tourn and the year, save in two cases: Spring 1430, 12 February at Hebburn, and Autumn 1433, 6 October at Wolviston, the steward, terrar and bursar being named in both, f.105v and 123v.

In addition to the principal contents concerning surrenders of, and entries to, holdings, there are leases of Heighington glebe manor with buildings on Coatsay Moor, land, meadow, moor and tithes in 1430, f.113r, and of tithes of flax, hemp and hay in Billingham parish in 1430, f.115v; records of fealty, f.65v-66r, 68v; attestations of earlier entries, f.105r (two); a memorandum of an earlier entry, f.125v; a memorandum of reductions in rent, f.96r; licences to occupy holdings, f.82v, 107r, 111r, 119v, 123r and 155v; an offer to occupy a holding, f.151r; recording of pledges, f.25v, 135v; wayleave for grindstones across Nether Heworth demesne from Semermosse quarry to the Tyne, f.21v; licences to sublet ( "tabernandi"), f.35v, 41v (two), 43v, 44v (four), 45r (three), 49v, 50r (two), 58r (two), 59v, 63r, 67r, 69v and 81r; inquests of neifty, f.18rv (two); a settlement over works due at the manor of Bewley from a freeholding in Wolviston, 1430, f.115; statement of the holdings, legitimate and usurped, of John of Hedworth, found in a somewhat fuller form in Cart.IV f.64r-65r, but here with the date 1345 "vt patet per Rentale" added after the day given for his exhibition of charters, f.72rv.

#### Halm.bk II Summer 1440 - Spring 1492

f.ir originally blank flyleaf. Added, over illegible erasures: Records of John Werdale's entry to a newly constructed holding, next to a holding of the Almoner [in Durham?], at Pentecost 1476; of Robert Jackson's entry on 15 September 16 Ed. IV [1476] to a house in Broom with a close and licence to sink coal pits; list of names [of tenants?], each with one or more cash sums.

f.iv, p.1-38\* Topographic lists of tenants on f.1r-202v below. The names, with folio references, were entered by township, starting with Willington and continuing in the order commonly used in the records of the main estate. To judge by ink changes between entries, compilation began c.1446 and was maintained with varying degrees of regularity. An alphabetical index of places was added s.xvi/xvii, p.1. p.5a back, 10, 21a back, 26, 36, 38 and 39 blank.

p.39 added in space: record of William Wright's entry to a cottage and close at Broom at Cuthbert in March 1484 [20 March 1485]; record of four tenants' entry to a new close on Spennymoor by Brownspiece at Cuthbert in March 1485 [20 March 1486]. f.1r-82v, 84r-202r Halmote court land transactions, Summer 1440-Spring 1492. There is nothing from the Summer tourn 1451 apart from the opening words of the heading, f.42v; nor from the Autumn tourn 1484 or Summer 1487. Entries for Southwick, Wearmouth etc. at the Spring tourn 1463 are missing through the loss of a leaf before f.85, see entries in the index, p.11-12. The entries of the Spring tourn 1463 are interrupted by material previously entered on f.83r, see below; f.83v blank. The entries for the Summer tourn 1440, f.1r-3r, are repeated on Halmote Book I f.159v-161v. The full headings from the halmote rolls are not generally given here. As well as the number of the tourn and the year, the full date is given for each tourn Summer 1462-Summer 1467, occasionally before that, and the month, sometimes with the date, for each tourn subsequently. The place is given for each tourn Autumn 1444-Summer 1447, and for most from Spring 1485 onwards. Up to Spring 1462 the names of the steward, terrar and bursar are usually included, and subsequently at the Summer tourn; the cellarer appears in place of the bursar at Spring and Summer 1445. In addition to the principal contents concerning surrenders of, and entries to, holdings, including one to be held of the master of the cell at Wearmouth, f.40rv, there are a considerable number of licences to occupy holdings; recording of pledges, f.145v, 150r; a note of an existing tenancy, f.45r; a pardon of arrears, f.8rv; note of condition voiding tenancies in the event of controversy between tenants, f.152v; note of rent to be paid, f.128v; note on cessation of repairs, f.154r; licences to sublet ("tabernandi"), f.17r, 19r, 20r, 65v, 117r (four), 134v, 137v, 138r and 153v; record of subletting, f.22v; memorandum of subtenancy, f.32v; licence to enclose 16 acres called Roughleyhill at East Merrington, f.145v; record of sworn testimony on the tenants of Pittington's right of access to Cocken moor, f.53v; inquests of neifty, f.76rv, 112v 113r; inquests on the manors of Belasis and Bewley, f.147r.

f.83r (entered on the last leaf of a quire prior to the entries on the preceding leaves) Record of court held in Durham, 12 May 1460. "Curia tenta in magna aula hospicij Dunelm die lune xijo die Maij Anno Regni Regis Henrici Sexti post Conquestum Anglie xxxoviijo coram Roberto Rodes Senescallo Domino Thoma Ayr terrario et Alijs". The entries concern affrays. f.83v blank.

f.202rv Record of entry to a plot at Willington for a salt works, [c.1495]. No indication of date is given; the hand is the same as that responsible for the entries of the preceding tourn, Spring 1492.

f.203r added, s.xv/xvi: Record of inquest into the holding of William Brown of Ferryhill deceased, 28 Jan.1481/2. Held before the prior's eschaetor, finding the heir to be Richard Brown, son of Hugh son of William's brother Roger, William having died 24 years previously.

The latter occurs frequently in the records of the Halmote court, taking the mill at Hesleden for 3 years from Martinmas 1368 at the Summer tourn 1368, and subsequently for similar, or shorter, terms, the last being a year's tenancy at the Autumn tourn 1385; another tenant appears at the Autumn tourn 1387. William Rois is more elusive; he was not one of the five tenants who took the mill at Southwick for 5 years from Martinmas 1375 at the Spring tourn 1376, nor the three, including John Reid, who took it for 3 years from Martinmas 1380 at the Summer tourn 1380, recorded in an entry that was added and then crossed out, but one of the two who took it over from John Reid for 12 years from Martinmas 1383 at the Summer tourn 1383, was William son of Adam, possibly identical with William Rois. This would fit well with the occurrence on this roll of William Chamberlain at Southwick: in the Halmote records his appearance there was brief, mainly in 1386, and, appropriately, in connection with the assize of ale.]

[The script indicates that this roll is to be dated to the latter part of the fourteenth century. Between 1350 and 1400 the feast of St Luke fell on a Thursday in 1352, 1358, 1369, 1375, 1380, 1386 and 1397. Evidence from the rolls of the Halmote court points to 1386 as being the most probable date. There seems to be no trace of John Dalgan miller as tenant of either of the mills at Aycliffe, unless he is identical with John de Haughton who took the fulling mill for 7 years at the Spring tourn 1370 and for a further 15 years at the Summer tourn 1377. John de Aycliffe miller at Burdon is, however, to be found taking the mill there for 9 years from Martinmas 1377 at the Spring tourn 1378, and he was succeeded by Robert Hapsamen, who took it for 8 years from Pentecost 1387 at the Autumn tourn 1386; whether John held it before 1377 is not clear, there being no entry for a tenancy after William Grampays and William Milner of Blackwell succeeded Richard Rath for 3 years at the Summer tourn 1371. While it is natural to date this section, and the three that follow it, to the months before the fully dated heading for 4 April 1392 below, none of the saints' days fell on Tuesday in 1391, but on Wednesday, Monday and Sunday respectively. Moreover, since the 1392 heading is in the same hand and ink as the heading here, it would seem that the roll was compiled from pre-existing records, which could have been shuffled. In 1392 the feast of Ronanus, 19 November, fell on Tuesday, but, while he best fits the description 'bishop', his feast was not normally used in the Durham records, and would put the sections dated by it after the Burdon section below. The simplest solution is therefore to assume that the feast of Romanus archbishop in 1391 was taken to be on Tuesday 24 October, rather than Monday 23 October.]
