Documents relating to the administration of the estates of the Howard earls of Carlisle in Northumberland and especially Cumberland, with occasional material for Yorkshire, and some personal, especially financial, material of the family.

Accession details

These are additional deposits, subsequent to the initial main deposit, coming in in 1967, 1971, 1982, 1995 and 1996, as detailed below.

Arrangement

One of the initial conditions of deposit of the main collection was that documents should be retained in their original order in their deposits, so this has been followed here with minimal sorting having been carried out and original numbering retained where applicable.

The Gubion [Morpeth High Common], showing Edington Ground, Parson's Close (a freehold), Midford Ground, Tranwell Ground, Sheilvington Gate, Saltweek Gate and Low Common Gate

Heddon on the Wall [enclosure map], surveyed and divided by William Dixon. Cartouche with flags and weaponry.

Clifton, Cadwell (Coldwell Hill) and Glorum (south of Morpeth), showing the post road, Tranwell Grounds, Catchburn Grounds, Hepscot Grounds, White House Grounds, Dove Coat House and Clifton Loaning.

Untitled, but shows a village (?Low Angerton) and has North Middleton, Heighly and Bolam on the boundaries.

High and Low Angerton, showing Harburn Grains Grounds and Long Witton Grounds on the boundaries; unfinished.

Shields Bank Head, showing a set of stairs, houses crowding along the quayside and a stylised picture of the River Tyne with boats on it.

Unfinished plan (?Hepscott north side), including a road with gates (Dunces House and Shadfen); no title or any text.

f.10br

Corner of a cartouche frame or box.

f.10bv

Untitled (?High Angerton), showing the confluence of the Hatsburn and the Wansbeck, Meldon Park Lands and Thornton Grounds.

f.11v-12br

Hepscott south side; detailed drawing (roads/footpaths) but little text.

f.12av-13r

Catchburn and Newbiggin showing Whorlton Moor Ground, Kenton Ground and Wissingdon (?Woolsington) Ground.

Killingworth Moor, showing Longbenton, Killingworth village, Salter Bridge, Scotsman's House, Fisher Gate, [the Holy Stone] and Haggerstone. Surveyed by William Cuthbertson jr. Incomplete or showing the moor unenclosed.

Longbenton, very detailed; apparently surveyed immediately after the division and enclosure of the ancient fields and common. Landowners named as Potts, Coulson, Atkinson, Parsons, Johnson and Lord Carlisle.

Field Head and Hay Close (east of Longhorsley), showing Yearsdon Lands (Earsdon, north of Morpeth), Horsley Moor, Paxton Dean Lands and Cawsey Park Grounds.
